**Weighting of College Level Courses:** Honors courses will continue to carry an additional .5 quality point. College level courses (e.g. AP, IB, Cambridge, DE) will continue to carry an additional 1.0 quality point.

**GPA Requirements for Student Organizations and Recognition:** The minimum NHS eligibility GPA requirement is 3.75 for grades 9 through 12. The minimum NJHS eligibility requirement is a 90% average in core courses for grades 6 through 8. The Honor Graduate GPA range is 3.5-3.99. The Distinguished Honors Graduate GPA is 4.0 or higher.

**Transcribing Grades for Transfer Students:** CBPS recognizes that different school districts and different states utilize different grading scales. As students transfer to CBPS, official transcripts are requested from the sending school. Grades are transcribed for transfer students based on the letter grade earned at the previous school. This letter grade for the transfer student is used to calculate the grade point average based on CBPS' quality point scale that is applicable. It should be noted that CBPS does not weight all courses.

#### **GRADING PROCEDURES**

CBPS grading procedures are put into place to clearly, accurately, consistently, and fairly communicate learning progress and achievement to students, families, postsecondary institutions, and prospective employers.

**Missed Work Due to Absences**: Upon returning to school, students will request any missed coursework. In partnership with the teacher, students will be responsible for collecting and completing all missed work. Students are granted a total of seven calendar days to complete assigned make-up work. Failure to meet this timeline may result in a zero. Exceptions and extensions may be given for extenuating circumstances.

**Missed Work Due to ISS:** Students will receive their work from their teachers for the day they are serving ISS.

Missed work due to OSS: Students are responsible for asynchronous learning while serving OSS, in addition to completing all classroom assignments given the day(s) of OSS. Assignments can be picked up in the front office the day following the assignment of OSS. Students are granted a total of seven calendar days to complete assigned make-up classwork. Work not completed may result in a zero. Exceptions and extensions may be given for extenuating circumstances.

**Retake Policy:** All students are afforded the opportunity to retake summative assessments (tests and unit tests) one time, within a seven day window following the date of the initial assessment. The highest grade will be reflected in the grade book. Students who failed the initial summative assessment will receive remediation before the retake; for such students, parent/guardian(s) will be contacted if students refuse the retake. Students who passed their assessment and want to take the retake must make the request within seven days. Exceptions and extensions may be given for extenuating circumstances.

#### **Grading Requirements:**

- A minimum of two grades per course will be assigned and entered weekly
- A minimum of three summative assessments (tests/projects) per course will be entered per nine weeks
- A minimum of two quizzes per course will be entered per nine weeks
- Teachers will ensure all weighted categories are included per a nine week grading period
- Grades will be updated weekly
- At the end of each quarter, if a student's grade is lower than a 50%, his/her overall average will be overridden to a 50%
- Courses accessed through Virtual Virginia, Edgenuity, or any other online platform are governed by the grading policies of that platform. Additionally, courses accessed through RCC, CBGS, NNTC, or any other campus outside of CBPS are governed by grading policies of that institution/organization.

### **HOMEWORK PROCEDURES**

Homework provides an essential communication link between the school and the home. One measure of a program or course is the quality of the work done at home by the student. A strong home-school partnership, with many lasting benefits for the individual student and his/her family, can be greatly enhanced by a sound program of homework. In addition, homework should be an important tool in developing independent thought, self-direction, and self-discipline. It can assist the student in developing good work habits and in the wise use of time.

PreK-7\*: Students are expected to read for twenty minutes per night and complete additional teacher assigned

tasks across other content areas (math, history, and science). Students should spend no longer than sixty minutes on homework. Independence is encouraged. Parents/guardian(s) should reach out to their child's teacher if homework is taking longer than sixty minutes to complete.

**Grades 8 - 12\*:** Homework is used as a compass to gauge student learning. Teacher assigned tasks across content areas are expected to be completed. Typically, students should not be assigned more than thirty minutes of homework per night, per class. Parents/guardian(s) should reach out to their child's teacher with concerns about the amount of homework being assigned or the length of time it is taking their child to complete homework assignments.

\*Additionally, students may also complete tasks from the regular school day that were not finished in class and/or study for assessments.
