Mrs. Payne moved to approve stipend #1 from the personnel recommendation list of July 17, 2019, as an Elementary School Physical Education teacher with a master's degree, to be paid 2,500.00 effective for the 2019 - 2020 school year. Mrs. Lyburn seconded and the motion was approved unanimously.
